Zakat

There are two kinds of charities in Islam:

- the obligatory
- the voluntary.

The **obligatory charity is called Zakat** while the voluntary charity is called **Sadqa**.

In Islam, the Zakat takes the form of a prescribed contribution based on a person's wealth and income. The rate of contribution varies with the kind of property owned but, on an average, works out to **2.5%** of the total value.

The proceeds of Zakat are supposed to be devoted towards relieving poverty, distress, and relieving other issues in the society.



Boyut-ul-Hamd Fund

Boyut-ul-Hamd Fund is a voluntary fund that is donated to the **homeless**. Hazrat Khalifatul Masih IV (rh) put forth the Boyut-ul-Hamd scheme before the Jama'at, which was meant to provide free accommodation to one hundred poor families.

Now, a hundred accommodation quarters have been built and provided for poor and deserving people. In addition, many poor members of the Jama'at have been partially aided to build their own houses. The repair and maintenance of these quarters is also ongoing.

Dar-ul-Yatama Fund



Hazrat Khalifatul Masih IV (rh) initiated this scheme by announcing that the Jama'at would take care of one hundred orphans and Jama'at members should donate generously towards this scheme.

Now this scheme is no longer confined to looking after one hundred orphans. The number of families being looked after has exceeded one hundred and the number of orphans is more than one thousand.



Humanity First

Established in 1995, Humanity First (HF) was registered with the UK Charities Commission and has expanded its operations in 62 countries, across 6 continents.

As a **relief organization**, HF aims to help millions of people in need in alleviating poverty, improving standards of living, refining health resources and promoting quality education to vulnerable communities. Their Mission is to serve disaster struck and socially disadvantaged individuals and families in the poorer communities of the world.

Majority of the aid workers and management are **unpaid volunteers** who recognize the significance and value in helping those less fortunate.



Eid Fund

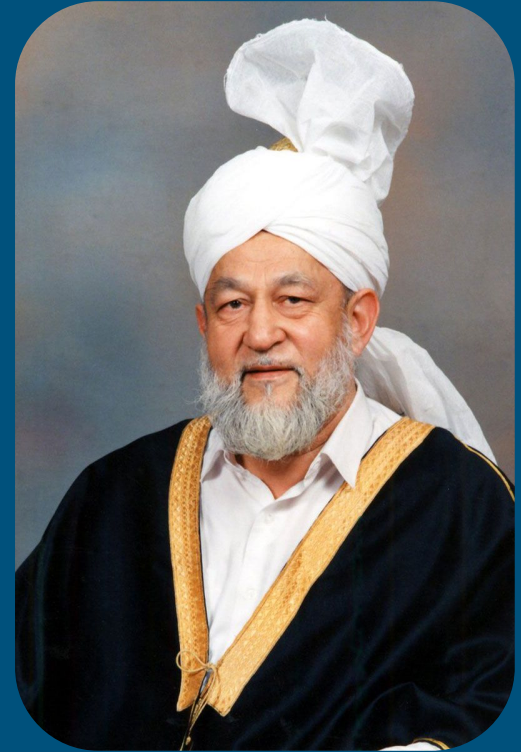
The practice of offering Eid fund exists since the time of Promised Messiah (as).

The aim of this fund was that just as on happy occasions a man spends money on things like clothes, food, parties and gifts, he should also bear in mind the requirements of faith and religion.



Maryam Shadi Fund

The Promised Messiah (as) set us free of the customs relating to wedding and funeral ceremonies, etc., with which our society was burdened. Whereas we refrain from such customs and spend on such occasions out of what Allah has provided us, we also have to bear in mind that there is a portion of our society which cannot afford to fulfil even the basic requirements on such occasions. It was in view of the needs of such people that Hazrat Khalifatul Masih IV (rh) launched a fund in his Friday sermon of 31st February 2003, which was later called the **Maryam Shadi Fund**. The amounts received under this head are used to help deserving parents in marrying off their daughters.



Syedna Bilal Fund

This fund was announced by Hazrat Khalifatul Masih IV (rh), in his Friday Sermon on 14th March 1982, for the **welfare of the families of Martyrs who have sacrificed their lives for the cause of Ahmadiyyat.**

“I would also like to reassure the Jama‘at that, by the grace of Allah, no Ahmadi who is killed in the cause of Allah, shall ever depart from this world thinking of what will become of his wife and children. In Jama‘at Ahmadiyya the children of such people do not become orphans. This is a living Jama‘at and it is impossible that it should forget its duty towards those who have sacrificed their lives. The guarantee of the life of such Jama‘ats lies in that fact that those who offer sacrifices should have no worry about those whom they leave behind.” - *Hazrat Khalifatul Masih IV (rh)*

Regarding the importance and great merit of this Scheme, Hazur said:

“This is not at all a Scheme for Sadqa. Rather whoever takes part in it will consider it an honour and will admit that still he has not done enough.”
